SUMMARY ANNUAL REPORT FOR ALASKA CARPENTERS DEFINED CONTRIBUTION TRUST FUND

This is a summary of the annual report for Alaska Carpenters Defined Contribution Trust Fund, EIN 92-6003157, Plan 002, for the year ended December 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the Plan are provided by a Trust. Plan expenses were \$12,329,840. These expenses included \$459,986 in administrative expenses and \$11,869,854 in benefits paid to participants and beneficiaries. Administrative expenses include administration fees, investment fees, auditing fees, attorney fees, banking fees, consulting fees and miscellaneous expenses. A total of 4,665 persons were participants in or beneficiaries of the Plan at the end of the Plan Year, although not all of these persons had yet earned the right to receive benefits.

The value of Plan assets, after subtracting liabilities of the Plan, was \$200,669,245 as of December 31, 2020, compared to \$179,648,431 as of January 1, 2020. During the Plan Year, the Plan experienced an increase in its net assets of \$21,020,814. This increase includes unrealized depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of \$33,350,654, including employer contributions of \$8,507,663, earnings from investments of \$24,811,048, and other income of \$31,943.

Funding Standards

Enough money was contributed to the Plan to keep it funded in accordance with the minimum funding standards of ERISA.
